### **Guidelines:**

- 1. The application process is open to all full time faculty members, post docs and registered students (graduate and undergraduate) in the Faculty of Health and Social Development.
- 2. The value of the award will be \$1700.00
- 3. Applications are due on March 1st, 2018 by 4:00pm. Please submit to helen.stychin@ubc.ca
- Applications will be reviewed by an award committee assigned by the Dean and the FHSD Research Committee.
- 5. Notification of the award recipients will occur on or before March 31, 2018.
- 6. The award recipient is expected to submit a brief report within six months after the date of the award establishment. The report should explain how the funds were used and next steps for the award recipient as applicable to cancer research. The funds must be used by March 31, 2019.

#### **Application:**

- 1. Applicants must be registered undergraduate or graduate students, post-doctoral fellows, or full time faculty members within FHSD.
- 2. Applicants must propose a project or program of research related to the prevention or cure of cancer in which the individual applicant has a specific role and objective.
- 3. Applicants must provide their curriculum vitae.
- 4. Applicants are requested to provide one letter of support from a colleague or supervisor highlighting the unique contribution the applicant brings to the cancer research project or programme. For student and post-doctoral applicants, a supervisor's letter should indicate the supervisor's approval of the proposal and verify the supervisor will provide an appropriate level of supervision to the student over the course of the project.
